- (3) I further agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the Code of Ethics, Constitutions, Bylaws and Rules and Regulations and duty to arbitrate all as from time to time amended.
- (4) I agree that if I subsequently resign or otherwise cause membership to terminate with an ethics complaint pending, that the Board of Directors may condition my right to reapply for membership upon my certification that I will submit to the pending ethics proceeding and will abide by the decision of the hearing panel.
- (5) I agree that if I resign or otherwise cause membership to terminate, that the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided that the dispute arose while I was a REALTOR®. If I resign or am expelled
- (6) I irrevocably waive all claims against the Board or any of its officers, directors, members, or staff for any act in connection with the business of the Board, and particularly as to its or their acts in electing, or failure to elect, advancing, suspending, expelling, or otherwise disciplining me as an applicant or as a member. Upon expiration of said membership for any cause, I will discontinue the use of the term "REALTOR®" and return to the Board all certificates, signs, seals or other indications of membership in the Board, the Utah Association of REALTORS® and the National Association of REALTORS®, and any other property of the Board in my possession.
