## **PURPOSE**

The **REALTOR® Hall of Fame Award** is organized to recognize outstanding sales performance, professionalism and participation by REALTOR® members of the Salt Lake Board of REALTORS®.

The **REALTOR® Distinguished Service Award** is organized to recognize dedication, participation, professionalism, education and service by REALTOR® Members of the Salt Lake Board of REALTORS®.

## **ELIGIBILITY**

Both awards are given annually and members must apply and qualify each year. All REALTOR® members of the Salt Lake Board of REALTORS® in good standing are eligible to apply.

### **REALTOR® Hall of Fame Award**

The applicant must have been a member of the Salt Lake Board of REALTORS® at the time the transaction closed in order to receive credit.

Members must have closed transactions of at least \$5 million or 25 closed sides. Members must also be able to verify that they have 50 points in participation in Board activities or RPAC donations during the calendar year.

Volume and closed sides will be calculated as follows:

- a. *If the property sold for \$100,000 and there were two agents involved, each would receive \$100,000 and one side.*
- b. *If the property sold for \$100,000 and one agent handled both the listing and the selling side, the agent would receive \$200,000 credit and two sides.*
- c. *This is an **INDIVIDUAL AWARD**. Only count sides and volume for which you are personally responsible.*

Only closed transactions and participation in the calendar year (January 1, 2008 and December 31, 2008) will be considered. Members must be able to prove their volume or number of transactions by providing an MLS print-out and submitting the participation form. On FSBO's, HUD transactions or any transaction that did not process through the WFRMLS, submit documentation, i.e., REPC, closing statements, etc. to verify your figures.

### **REALTOR® Distinguished Service Award**

The Distinguished Service Award is given annually to members who have demonstrated professional and educational accomplishments, participated in the political process by making RPAC contributions, or have actively participated in Salt Lake Board and other REALTOR® functions. A minimum of 50 points is required for this recognition. This award does not have any sales performance requirement.

### **AUDIT AND VERIFICATION OF APPLICATION**

The Salt Lake Board reserves the right to randomly audit applications and verify any or all sales reports and participation forms. If the application does not have the MLS printout attached or the participation form completed, the application will be rejected. Brokers should carefully review all applications prior to attaching their signature. **Any member who is found to have manipulated figures from the MLS printout or participation form will be disqualified from applying for any future Salt Lake Board of REALTORS® Awards.** All decisions are final and not subject to further review.

When an agent has worked for more than one office during the eligibility period, both brokers must certify sales made while in his or her office.

THE DEADLINE TO SUBMIT APPLICATION AND VERIFICATIONS IS FRIDAY, JANUARY 16, 2009.
